# LEGISLATIVE UPDATES AND ISSUES RECENT HOUSE BILLS

Congress recently passed three pieces of legislation supported — S.1393, the Jobs for Our Heroes Act, S.925, the Veterans E-Health and Telemedicine Support (VETS) Act of 2017, and H.R.4323, the Supporting Veterans in Science, Technology, Engineering, and Math (STEM) Careers Act. S.1393 amends existing law in order to allow VA physicians and nurse practitioners to provide medical certifications to veterans who currently operate or wish to operate commercial vehicles. Additionally, it applies commercial driver's license standards for former members of the armed forces to current members. Passed by both the House and Senate, this bill now goes to the president. S.925, passed by the Senate, amends Title 38 to improve the ability of licensed health care professionals employed by VA to treat veterans via telemedicine at any location in any state, regardless of where the professional and patient are located. H.R. 4323, passed by the House, directs the National Science Foundation (NSF) to promote veteran involvement in STEM education, computer science, and scientific research by increasing outreach to veterans and by expanding certain NSF scholarships, grants and fellowship opportunities to veterans and military families.

### NOTABLE SUCCESSES FOR MILITARY

- A 2.4-percent active duty pay raise
- Unchanged Basic Allowance for Housing (BAH) calculation
- More troops authorized
- Permanent extension of Special Survivor Indemnity Allowance (SSIA)
- Defeated VA's proposed elimination of individual un-employability benefits for veterans after they reached Social Security retirement age; MOAA pushed back, and the VA decided to not pursue the cuts.
- Defeated a Congress-proposed bill to require service members to buy into the Post-9/11 GI Bill; MOAA spoke out in opposition, and Congress found the needed funds elsewhere

Note, additionally, both the Senate and the House Veterans' Affairs committees passed their respective pieces of legislation to reform the VA health care system and community care programs. Unfortunately, passing tax reform and stop-gap funding caused the sidelining of these bills until January 2018.

# MILITARY RELATED ITEMS FROM NEW TAX REDUCTION AND JOBS ACT

**Exception to the repeal of the moving expense deduction**: While the deduction is generally suspended through 2025, the provision retains the deduction for moving expenses and exclusions for in-kind moving and storage expenses (and reimbursements or allowances for these expenses) for members of the armed forces (or their spouse or dependents) on active duty moving pursuant to a military order and incident to a PCS.

Striking the change to the exclusion of gain of sale of a principal residence: This provision would have lengthened the time requirements for principal residency in a home such that service members, who move more frequently than civilian counterparts, would not have any reasonable expectation of benefiting from tax-preferred gains on the sale of a home. The provision was dropped from the bill. Striking the repeal of the Work Opportunity Tax Credit (WOTC): The WOTC has been a critically important tool assisting in solving the problem of veteran unemployment. Department of Labor statistics show 35,904 veterans were certified for WOTC during the three-year period before the Veterans Opportunity to Work Act of 2011. By contrast, 278,611 veterans were certified during FYs 2013-15, an increase of nearly 700 percent. The provision repealing WOTC was dropped from the bill.

Adjustments to and extension of the medical expense deduction: Contrary to the original proposal to completely eliminate the medical expense deduction, the deduction floor will be decreased from 10 percent of adjusted gross income to 7.5 percent for 2017 and 2018. After that, it will return to the 10-percent floor.

#### WWI MEMORIAL UPDATE

On Nov. 9, the U.S. WWI Centennial Commission hosted a ceremonial groundbreaking for the National WWI Memorial at Pershing Park, a block from the White House on Pennsylvania Avenue. The memorial could cost up to \$40 million and is expected to be completed by Nov. 11, 2018. Fundraising, including sales of a WWI commemorative coin produced by the U.S. Mint, is underway. Keynote speakers used shovels to turn dirt from the Meuse-Argonne battlefield in France, site of the largest military battle in U.S. history. More than a million Americans fought in the offensive.

Joe is currently a part-time volunteer docent at the Texas Civil War Museum. His specialty includes weapons and uniforms. He also performs period music. Joe is a researcher and enjoys helping those interested in civil war history.

Joe was born and raised in Atlanta Georgia, Joe joined the Navy shortly after high school and served in two fighter squadrons during the Vietnam War. After the Navy, he received his BA degree from Georgia State University and moved to Texas. He retired in 2005 as a vice-president of a national distribution company.

Joe is a member of the Company of the Military Historians, Sons of Confederate Veterans, Order of the Southern Cross, and the Sons of the American Revolution. Joe was a reenactor for over 35 years including participation in living history evens at many national and state battlefield sites. He has contributed to several books and has served as an advisor for civil war artists. Joe received the Jefferson Davis Gold Medal for confederate flag research from the United Daughters of the Confederacy. He has been a collector of civil war memorabilia for many years. He has served on the advisory board of the Heritage Museum at Hill College. Joe and his wife have three grown children and have lived in Woodway since 1979.

#### TOP TEN GOALS OF NATIONAL MOAA

- 1. Ensure any TRICARE reform sustains access to top-quality care.
- 2. Prevent disproportionate TRICARE fee increases.
- 3. Sustain military pay comparability with the private sector.
- 4. Block erosion of compensation and non-pay and quality-of-life benefits.
- 5. Protect military retirement and COLA's.
- 6. Sustain wounded warrior programs and expand caregiver support.
- 7. End financial penalties to survivors and the disabled.
- 8. Ensure the Guard and Reserve system adequately supports the requirements for an operational reserve.
- 9. Ensure spouse and family support programs are aligned with current and emerging needs of an all-volunteer force.
- 10. Ensure timely access to VA health care and preserve earned veterans benefits.

# FIVE KEY POLICY DECISIONS IN THE FY 2018 NDAA

A 2.4-percent active duty pay raise: This pay raise, equal to the Employment Cost Index (ECI), helps keep troops' pay competitive with private-sector wages. The administration originally requested a 2.1-percent raise - MOAA influenced Congress through a very effective and successful campaign to fully support the higher pay increase. This is the highest pay increase for troops since 2010. Even with this pay increase, a 2.6-percent pay gap remains because of capped pay raises in FYs 2014, 2015, and 2016.

**TRICARE:** Despite yearlong efforts to prevent TRICARE fee increases, the final NDAA included progressive year-over-year increases in pharmacy copayments. Beneficiaries will see steady increases in their cost shares across all medication tiers, which will save DOD more than \$2.1 billion by 2022 and fund improvements in military readiness and the Special Survivor Indemnity Allowance (SSIA). Most of the increases will be through the retail pharmacy sector, but beneficiaries still can obtain medications at military pharmacies for free. The new fees will include mail-order generic prescriptions as well. By 2026, costs are projected to top off at \$14 for a 30-day supply of a generic medication at a retail pharmacy and a 90-day supply by mail. Further, a 30-day supply of a nongeneric medication at a retail pharmacy will be \$48, and a 90-day supply by mail will hit \$44.

Additionally, outside of the NDAA provision, the Defense Health Agency has introduced a new TRICARE fee structure that will be applied to the new TRICARE Select option. Increased fees also will apply to the existing TRICARE Prime option. Beneficiaries can view these changes at <a href="https://tricare.mil/About/Changes/Costs">https://tricare.mil/About/Changes/Costs</a>.

These changes to the TRICARE fees and program options will take effect Jan. 1, 2018.

Unchanged Basic Allowance for Housing (BAH) calculation: The Senate tried for the second year in a row to tweak the calculation for BAH in a way that would have negatively impacted service members, particularly dual military families. BAH is a component of each individual service member's earned compensation, so the calculation will stay as it currently is in law.

More troops authorized: The FY 2018 NDAA authorizes an additional 20,000 troops - much needed by the services in the current and projected national security environment. The Army will increase by 7,500, the Navy by 4,000, the Marine Corps by 1,000, and the Air Force by approximately 4,100. Reserve forces across-the-board will grow by about 3,400.

Lessens the "widow's tax": Congress included a provision in the FY 2018 NDAA that provides a permanent extension to the SSIA. Without congressional action, 67,000 military survivors would lose \$2,100 in 2018 if the allowance expired in May, as it was set to, and over \$3,700 a year after that. By extending the SSIA and indexing future increases to COLA, Congress shows it is making a good-faith effort to address the widows' tax.

# **LOWER TRICARE ELECT COPAYMENTS**

The Defense Health Agency (DHA) reduced copayments for the new TRICARE Select plan. DHA initially announced the new copay concept and costs, which will replace the percent-of-servicesused model in place under TRICARE Standard and Extra, in the Interim Final Rule released in September. The new copay scale released today shows a reduction in the cost of Group A primary care visits from \$27 to \$21 for active-duty family members, and from \$35 to \$28 for retirees. Group A beneficiaries are those who were in uniform or retired prior to the Jan. 1, 2018, implementation date. Similar reductions will be seen in specialty care, urgent care, emergency room visits, and ambulance service. The new copay amounts were included in the "Notice of TRICARE Prime and TRICARE Select Plan Information for Calendar Year 2018." The document also includes details on new covered care, enrollment requirements, and a change in the urgent care referral requirements.
