#### PRESIDENT'S COLUMN

We received at least 23 applications, and our application packages are thorough and comprehensive. Our process is not a simple "prize drawing", but involves reading essays and questionnaires applicants submitted. I want to give a big salute to Harold Rafuse who assembles the screening committee and has built the scoring process over the years that considers each applicant fairly. The task is daunting and we want to ensure the selected scholarship recipients meet the spirit and share the values we adhere to in MOAA. Thank you to each member of the scholarship committee!

Despite what the media reports, bills are being worked in Congress and the President is signing new legislation. The Military Officers Association of America reports on the success of MOAA backed legislative proposals. The House and Senate are currently working the National Defense Authorization Act and key MOAA goals include increased end strength levels, basic pay increases, defined protections for service members from domestic violence and other violent crimes, no increase to TRICARE fees, protection of basic allowance for housing, aid for severely disabled military children, and modernization of the Defense Officer Personnel Management Act. Of interest to

veterans, Congress passed a bill to streamline the VA health care system, which could reduce veterans' wait times and allow more of them to seek out their own physicians. If you do not subscribe to MOAA's weekly updates, you can sign up by going to the MOAA website.

With regret, I report the passing of Libby Rochelle. When reading Libby's obituary, I was struck by the account of an amazing woman, wife, and mother living a life of adventure with her husband for over 40 years. # PRESIDENT SIGNS HISTORIC LEGISLATION TO IMPROVE VETERANS HEALTH CARE

President Trump has signed the VA MISSION Act of 2018. "The VA MISSION Act will help improve the care our veterans get at the VA while leveraging the capabilities of the private sector when needed. It will help recruit the best talent at the VA, which is what our veterans deserve, and it also extends caregiver benefits to every veteran who needs it," said Keith Harman, national commander of the 1.7-million member VFW and its Auxiliary. The VA MISSION Act was the result of a bipartisan and bicameral effort led by Senate Committee on Veterans' Affairs Chairman Sen. Johnny Isakson, Ranking Member Sen. Jon Tester and House Committee on Veterans' Affairs Chairman Rep. Phil Roe, M.D.

Some of the major provisions in the act include:

- expanding the VA's comprehensive caregiver support program to pre-9/11 veterans, providing eligible caregivers additional support services and a monthly stipend;
- eliminating the broken Choice program and establishes one community care program called the Veterans Community Care Program;
- allowing veterans and their doctors to choose the best option on where to get health care whether in the VA or from one of the providers in the VA's community care network;
- streamlining eligibility standards so veterans have greater choice, doing away with the former distance and wait-time restrictions;
- investing in the VA's workforce to attract and retain high-quality health care providers;
- expanding access to telehealth care closer to home;
- establishing mobile deployment teams to help provide additional care to the VA facilities with the highest need;
- recruiting medical scribes to help physicians focus on serving veterans, rather than spending time on paperwork;
- establishing a walk-in care benefit in the community for veterans in need of nonemergency care;
- establishing a commission to review and recommend realigning of resources to strengthen and modernize the VA medical infrastructure to address the needs of the changing veteran population.

### VA FUNDS EFFORTS TO REDUCE INTIMATE PARTNER VIOLENCE

VA has committed to adding \$17 million in spending to strengthen the Intimate Partner Violence (IPV) Assistance Program across the nation. Research shows that IPV, which is physical, sexual or psychological harm by a current or former partner, may be a greater risk for veterans than for non-veterans. The current program is a holistic approach that includes understanding, recognizing and responding to the effects of trauma with the goal to prevent further violence and promote healthy relationships. The program was established in 2014 and offers intervention through VA and community partners to address housing, education and employment needs. The increase in funding will expand the program from 115 facilities to all VA medical centers, and help to increase awareness of IPV as a serious issue within the veteran community.

# WHITE HOUSE APPROVES INTERAGENCY PLAN ON SUCIDE PREVENTIONS

President Donald Trump recently approved an interagency plan to implement an executive order offering support to veterans with mental health care and suicide prevention resources for one year during their transition from military to civilian life. VA, DOD, and the Department of Homeland Security were required to develop the plan by an executive order signed by President Trump in January, which directed the agencies to collaborate in efforts to reduce the rate of suicide among recently discharged veterans. Research has shown that veterans are at a higher risk of suicide and mental health crisis during the first year of their transition to civilian life.

#### **D-DAY COMMEMORATION**

On Wednesday, June 6 at 11a.m., the Friends of the National World War II Memorial hosted a ceremony at the World War II Memorial in Washington D.C., to recognize the service of the some 160,000 Allied troops that landed on the beaches of France 74 years ago. In attendance were approximately 10 D-Day and WWII veterans who placed wreaths to honor the sacrifice of the 9,000 soldiers, sailors, airmen, and Marines who were killed during the invasion.

#### JUNE 12<sup>TH</sup> WOMEN VETERANS DAY

This date commemorates the 70<sup>th</sup> anniversary of the Women's Armed Services Integration Act signed into law by President Harry S. Truman on June 12, 1948.

It is the role of the Texas Council, as well, to advocate for the benefits, welfare and pay of those represented to our Senators and Representatives in the US Congress

and the same in the Texas Legislature. This is done regardless of political parties; MOAA is strictly apolitical! MOAA National's mission is Congressional advocacy; the State Council's mission is both Congressional advocacy and advocacy is the State Legislature. Join us in our effort; you can make a difference!

At present, the Texas legislature does not formally meet in session until 2019. However, various committees still continue to meet on a regular basis and TCC members are involved at times to provide information at meetings on veteran issues. In preparation for the coming 2019 session, TCC planning has started on one possible veteran issue to advocate. This involves trying for property tax relief with deduction based on a veteran's VA disability percentage. A modified proposal was pushed in 2017 session to gain this for 80 and 90 percent disabled veterans but it did not proceed in legislation for a vote. Efforts will continue to try again but takes much coordination and active support in the busy and bill-packed Texas session process.

#### **TEXAS VETERANS COMMISSION**

The mission of the Texas Veterans Commission is to advocate for and provide superior service to veterans that will significantly improve the quality of life for all Texas veterans, their families, and survivors. The web site is www.tvc.texas.gov

#### **KOREAN WAR REMEMBRANCE**

The Korean War began 68 years ago in June and the shooting stopped 65 years ago in July. While an armistice was signed July 27, 1953, the war did not end and that remains true to this day. On average, about 30,000 U.S. troops serve in South Korea each year and U.S. troops would immediately be on the front lines in case of conflict.

The creation of the Korean War Veterans Memorial in Washington, D.C. remembers the sacrifices made during the conflict. It was dedicated in 1995. Approximately 1.5 million U.S. veterans served in the Korean War and 36,576 died there.

#### GUEST SPEAKER – BOB LULL

Bob Lull is a retired U.S. Army lieutenant colonel, with more than twenty-two years of active service. His military career included responsibilities as a platoon leader, company commander, battalion commander, and numerous staff positions. He served two years in Vietnam, one in Korea, four years in Germany, three years on the staff of the US Military Academy at West Point, brief assignments in Ecuador, Panama, and various other locales. His other assignments include duties at Fort Bliss, Texas; Austin, and Atlanta. He has served in multiple assignments at Fort Sam Houston, in San Antonio.

After retiring from the Army, Bob embarked on a career in the healthcare field at the executive level in a number of hospitals, major teaching institutions, and as chief financial officer and managing partner in a healthcare support services consulting company. He was recognized for his accomplishments and designated as a Fellow in the American College of Healthcare Executives. After his years in healthcare, in 2007, he followed still another path teaching American History at McLennan Community College in Waco. He is the author of the award-winning book *Civil War General and Indian Fighter James M. Williams*.

Bob is a graduate of Trinity University, and holds advanced degrees from the University of Texas, Webster University, and the American Military University. He is also a graduate of the U.S. Army Command and General Staff College.

Bob and his wife, Penny, have been married for fifty-three years. They have two sons and three granddaughters. Penny has recently retired as a teacher at St. Paul's Episcopal School, and Bob is working on a book about four brothers in Texas history named Baylor.

The April 2018 CPI is 244.607, 2.1 percent above the FY 2018 COLA baseline. The CPI for May 2018 is scheduled to be released on June 12. The Consumer Price Index is used to annually adjust pay for military and federal retirees, survivors, and Social Security recipients.

### MEMORIAM FOR EIZABETH "LIBBY" ROCHELL

Elizabeth "Libby" A. Leggitt Rochell passed away Tuesday, May 29, 2018. The memorial service and interment were held on June 4 at St. Paul's Episcopal Church, Waco, Texas.

Libby was born November 30, 1940, in Marshall, Michigan, to Samuel H. and Mildred Leggitt. Because of Libby's health issues, her father moved the family to San Marcos, Texas, when Libby was eight years old. She graduated from high school, Class of 1958, and then she attended Stephens Girl College, majoring in voice for one year. She then attended one year at Southwest Texas State University and graduated from TCU with a degree in nutrition. After a short stint as a manager of Hallsberg Cafeteria, she was accepted as a nutritionist with the Texas State Health Department long term care division. There she joined a team that inspected nursing homes until she retired.

Libby married Robert Rochell on February 18, 1978, and had just celebrated their 40th anniversary by having dinner in Honolulu, Hawaii, at Alan Wong Gourmet Restaurant. She loved to travel, having traveled to over 100 countries and islands. Her favorite place to visit was Bangkok, Thailand, that she visited four times, and where she loved to shop. Libby's favorite hobbies were traveling, gardening, and yes, she loved jewelry.

Also, she had many friends from various clubs around the country. She served on the Altar Guild at St. Paul's Episcopal Church for many years, and East Terrace, Historic Waco, and DAR. She was a member of the Honorable Order of Molly Pitcher. During the war with the British, Molly was the person carrying pitchers of water to cool the cannons and provide water for the soldiers. When her husband was killed, she took his place as the gunner. She was commissioned by George Washington for her heroism and bravery.

She was preceded in death by her parents.
She is survived by her husband, Robert
Rochell; daughter, Tracy Webb and Mark Gilmore
of San Marcos, and Pam and Yeager of McGregor;
brothers, Hunter Leggitt and wife, DJ, of Chicago,
and Buzz Leggitt of San Marcos; granddaughter,
Brittany Kelley of Hewitt, Texas; and grandson,
Graham Harvey of San Marcos.

Libby was determined, extremely strongspirited and was well liked by everyone and was an inspiration to all. She defied all odds many times. Libby loved life!
