BLUE WATER NAVY VIETNAM VETERANS ACTO OF 2019 SIGNED

Long-sought legislation that will extend disability benefits to about 90,000 veterans who served off Vietnam's coast during the war was signed into law June 25 by President Donald Trump. The Blue Water Navy Vietnam Veterans Act of 2019 will extend the presumption of exposure to toxic defoliants such as Agent Orange to these service members, which will allow them to receive care for types of cancer and other illnesses linked to these chemicals. MOAA and other veteran service organizations, including Disabled American Veterans, Veterans of Foreign Wars, the American Legion, and the Fleet Reserve Association, have championed the bill, which failed to clear Congress in previous sessions.

"This is great news and rectifies literally decades of oversight to tens of thousands of veterans who have been denied of the appropriate medical care and compensation from their exposure to toxic chemicals during combat operations," said MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret). "Hopefully, this sets the stage for future considerations of toxic chemical exposure and mandates both effective documentation and treatment for those service members exposed to these dangers."

The legislation passed the House on May 14 and the Senate on June 12. In January, a Federal Circuit court ruling granted presumptive exposure to Blue Water Navy veterans who served within the territorial waters of Vietnam; a motion in a separate court case, filed between the House and Senate votes, confirmed the VA would not appeal that ruling.

The act includes coordinates that define "offshore of Vietnam" for the purposes of the benefit. It also extends benefits to veterans exposed to Agent Orange on the Korean DMZ, and it expands benefits to those suffering from spina bifida who had a parent who served in Thailand during the Vietnam war. These groups were not covered by the court ruling.

VA Secretary Robert Wilkie recently told a Senate committee that the VA began processing benefit claims from Blue Water Navy veterans before the legislation passed, according to Military Times.

SENATE PASSES FISCAL YEAR 2020 NDAA

The Senate recently passed National Defense Authorization Act of Fiscal Year 2020 supports a total of \$750 billion for national defense programs, including those at the Department of Defense and Department of Energy national security programs. Highlights of the legislation include:

- Providing for a 3.1 percent pay raise for our 2.15 million uniformed service members the largest in a decade;
- Reforming the Military Housing Privatization Initiative to improve quality of life for military families;
- Authorizing critical investments in battle force ships, aircraft, and other equipment to maintain our combat advantage;
- Maintaining a secure, credible nuclear deterrent;
- Supporting our allies and partners to counter strategic competition;
- Establishing the United States Space Force under the Air Force;
- Modernizing our military technology and capabilities, including artificial intelligence and hypersonic weapons; and
- Advancing the Department of Defense's cybersecurity strategy and addressing our cyber warfighting capabilities.

WHITE HOUSE VA HOTLINE UPDATE

The U.S. Department of Veterans Affairs' new telephone hotline for veterans eclipsed 250,000 phone calls and spread its operation into a sprawling office complex in the mountains of Shepherdstown, West Virginia. The hotline initiative was announced in 2017 amid criticism from veterans and veteran service organizations about the challenges of reaching VA representatives by phone. The White House VA Hotline, which first opened as a small operation in the basement of VA headquarters in 2017, has rapidly grown in size, staff and call intake. The hotline – 1-855-948-2311 is staffed by operators, 90% of whom are veterans. The 24-hour hotline accepts calls from veterans nationwide. It has received over 250,000 calls since its inception in 2017. Operators said a large number of calls come from veterans with questions about claims, benefits or prescriptions, including medications that hadn't arrived on time. The VA's Choice program and its new Mission Act, both of which allow veterans to seek non-VA care for some medical needs, also produce a growing number of calls, employees said.

NOTE ON AFGHANISTAN AND NATO

Ongoing support to Afghanistan was "high on the agenda" as NATO's defense ministers, including the United States' new acting Defense Secretary Mark Esper, gathered in Brussels for a ministerial meeting June 26-27. NATO Secretary General Jens Stoltenberg acknowledged that "roughly half" of the troops participating in the Resolute Support mission there are from the US, saying the best way NATO can support the peace effort is to remain committed to the train, advise, and assist mission there. That's why the Alliance has committed to financially support Afghan Security Forces through 2024 and is preparing to send another rotation of troops to the country in the near future. "We will stay in Afghanistan for as long as necessary, to ensure the country never again becomes a safe haven for international terrorists," Stoltenberg added. His comments come days after two US soldiers were killed in combat operations in Afghanistan, prompting a rather heated exchange amongst democratic presidential hopefuls on June 26 about the merits of remaining in the country.

EXHIBIT AT BAYLOR MAYBORN MUSEUM

SpaceX has become a vital part of the industrial and social fabric of central Texas. This new exhibit features a rocket model and thruster engine, projection video, vibrant scale representation of our solar system, and some history of the rocket development and test facility in the local community of McGregor, TX. Because, as we like to say: To go to Mars, you have to go through McGregor.

This exhibit was made possible through generous support and collaboration from SpaceX, and will be on display through fall 2019.

COLONEL DYKE PASSES – HAD BEEN OLDEST LIVING WEST POINT GRADUATE

Air Force Col. Kermit Robert Dyke – a World War II pilot, MOAA Life member, and the oldest living graduate of the U.S. Military Academy – died late last month in his hometown of Solomons, Md. He was 104.

Dyke began his military career after he graduated high school in Los Angeles in 1932, during the Great Depression. He didn't want to end up like the scores of men he saw lined up looking for work every day, according to a 2017 profile in the Washington Post.

He joined the National Guard, which helped him enter the U.S. Military Academy in 1936. He enjoyed his time at West Point, where he learned to foxtrot and spent time firing guns, eventually earning a spot on West Point's pistol team. But he didn't like waking up at 6 a.m. or being told not to look at his food when he ate so he wouldn't feel pampered, according to the Post feature.

Dyke served as a pilot with Army Air Corps and later the Air Force. He was trained to fly more than 40 different aircraft and flew missions over Africa, Sardinia, France, and Italy during World War II, according to an obituary in The Calvert (Md.) Recorder.

Over his 22-year-career, Dyke served at installations in Virginia, Canada, Missouri, and Colorado.

Dyke was active in local associations and in West Point alumni affairs, serving as the Class of '40 president. In May 2018, Dyke led the West Point alumni parade as its oldest living graduate. In February of that year, his wife, Barbara Williams "Bobbe" Dyke, died at age 91; they were married in 1951.

THE DAY THE WORLD STOPPED

An estimated 530 million people around the world watched and listened on July 20, 1969 as Apollo 11's lunar module touched down at 4:17 EDT. About six hours later, Neil Armstrong took "one small step for man, one giant leap for mankind" – as Buzz Aldrin prepared to join him and Michael Collins waited alone in the skies above for their return. Only 12 astronauts walked on the moon, but inspiration spurs us 50 years on to shoot for Mars, while never tiring of sentences that begin, "They can put a man on the, but..."
