SCAMMERS COST MILITARY RETIREES AND VETERANS \$68 MILLION LAST YEAR

Military retirees and veterans far outpaced other members of the military community when it comes to damage done by financial fraud in 2020, according to federal data released in July, with \$68 million reported lost to various scams.

That figure nearly doubles the combined losses reported by active duty service members (\$13 million), National Guard and Reserve members (\$6 million), and spouses or dependents of active duty members (\$17 million) according to data from the Federal Trade Commission's Consumer Sentinel Network. Of the 66,383 fraud reports received from military consumers, nearly 29,000 were imposter scams, which can range from fraudsters impersonating Social Security or IRS officials to posing as family members or potential romantic partners to gain trust and ask for money. These scams cost military consumers \$41.3 million last year.

Other types of fraud at the top of the list:

- Fraudulent prizes, sweepstakes, and lotteries accounted for \$12.3 million in losses in 2020.
- Scams connected to online shopping or negative reviews led to \$8.1 million in losses.
- Fake business or job opportunities resulted in \$6.7 million in losses, as did fraudulent travel, vacation, and timeshare programs. The second group had the highest median loss rate (\$2,475) of all categories.
- One of our members got several e-mails about an I-Pad for \$1,289 he supposedly had ordered and to call a number to get a refund. When he called, the foreign sounding voice insisted he type in a site link, which he did not do. The rep got angry when the member did not proceed, given the site likely involved suspect ransomware or worse. Needless to say, need to stay vigilant

NAVY CAPTAIN MAKES HISTORY AS FIRST WOMAN TO COMMAND AN AIRCRAFT CARRIER

Capt. Amy Bauernschmidt, USN, became the first woman to take command of a nuclearpowered aircraft carrier Aug. 19 at a change-ofcommand ceremony for USS *Abraham Lincoln* (CVN-72) in San Diego.

Bauernschmidt, who was tapped for a 2022 carrier command in December along with five fellow officers, served as the carrier's executive officer from 2016-2019, the first woman to serve in that capacity aboard a nuclear-powered flattop. She recently commanded USS *San Diego* (LPD-22), an amphibious transport dock.

"There is no more humbling sense of responsibility than to know you are entrusted with the care of the people who have chosen to protect our nation," Bauernschmidt said at the Aug. 19 ceremony, according to a Navy press release. She also thanked outgoing commanding officer Capt. Walt "Sarge" Slaughter for turning over "the finest ship in the fleet."

Bauernschmidt graduated from the U.S. Naval Academy in Annapolis, Md., in 1994 and was designated as a naval aviator in 1996, according to her Navy bio. She has racked up more than 3,000 flight hours in naval aircraft.

DOD MANDATES COVID VACCINATIONS

Secretary of Defense Lloyd Austin outlined details of DOD's mandatory COVID-19 vaccination protocols in an Aug. 24 memo, including a desire for "ambitious timelines" from the service branches for full implementation.

"Mandatory vaccinations are familiar to all of our Service members, and mission-critical inoculation is almost as old as the U.S. military itself," Austin wrote. "Our administration of safe, effective COVID-19 vaccines has produced admirable results to date, and I know the Department of Defense will come together to finish the job, with urgency, professionalism, and compassion."

News of the memo was first reported by The Associated Press. The policy update was expected after the full approval Aug. 23 by the Food and Drug Administration (FDA) of the Pfizer vaccine. While DOD will use only fully approved vaccines as part of its inoculation program, service members who have received COVID-19 vaccines approved under emergency use authorization by the FDA or the World Health Organization are considered fully vaccinated, per the memo.

Service members with a previous COVID-19 infection aren't exempt from the vaccine. Service members participating in vaccine trials are exempt from the requirement so as not to affect the results of those trials. Service members seeking other types of exemptions must do so through their service branch, Pentagon Press Secretary John Kirby recently told members of the media.

More than 1 million service members are fully vaccinated, according to DOD data. The service has enough Pfizer vaccine for the rest, according to the Associated Press report on the memo, which estimates more than 800,000 service members are not yet fully vaccinated.

MEDICARE PART B COST ESTIMATED INCREASES

Your Medicare Part B costs will increase by about 6% next year, according to estimates in a Congressional Research Service (CRS) report projecting premiums through 2029.

That rate of increase would remain fairly steady through the coming decade, per the report, with most beneficiaries seeing a 57% overall increase from their 2021 premiums to their 2029 rates.

Most Medicare Part B users – those whose tax returns in 2019 were \$88,000 or less for an individual tax return (or married but filing a separate return) or \$176,000 for a joint return – are paying \$148.50 a month in 2021. That beneficiary bracket would pay \$157.70 per month in 2022 under CRS estimates, and \$234.10 in 2029.

In addition to this group, there are five levels of higher-income beneficiaries who pay higher Part B premiums based on reported income levels. These income levels will rise yearly; the CRS report does not estimate the incomes assigned to each level in future years.

<u>MENTAL HEALTH RESOURCES</u> <u>AVAILABLE FOR VETERANS</u> <u>UNSETTELED BY AFGANISTAN NEWS</u>

Advocates are reminding veterans that help is available if headlines about the disastrous end of the U.S. mission in Afghanistan the looming Sept. 11 anniversary are triggering anxiety and mental health issues.

"Veterans should be on the lookout for red flags if news of Afghanistan starts changing behavior," Dr. Sonya Norman, director of the Department of Veterans Affairs' PTSD Consultation Program, said in a statement late last week. "These include isolating, using alcohol and drugs or any increase in unhealthy behaviors compared to normal."

Even before the collapse of the Afghan government over the weekend, VA officials had been preparing for increased requests for mental health care and trauma assistance amid the ongoing U.S. military withdrawal from the country.

About 1.9 million post-9/11 veterans are currently enrolled in health care with the department. A 2014 study by department officials found that nearly 16 percent of all veterans who deployed to Iraq or Afghanistan screened positive for post-traumatic stress. Both VA and Defense Department officials in recent years have worked to eliminate the stigmas surrounding mental health care, noting that PTSD and related issues can be handled if individuals acknowledge they are facing personal difficulties.

The department has been running a series on mental health issues on its official blog, including a feature on lessons learned from the aftermath of the Vietnam War for veterans struggling with unresolved medical issues.

The Veteran Crisis Line is also available around-the-clock at 1-800-273-8255 (veterans should select option 1 for a VA staffer.) Veterans, troops or their family members can also text 838255 or visit VeteransCrisisline.net for assistance.

Numerous lawmakers and congressional committees shared the crisis line number on social media on Monday, thanking veterans for their service and letting them know help is available.

Veterans' service organizations are also stepping up their outreach efforts in light of the unsettling news overseas.

In a statement Monday, officials from Wounded Warrior Project noted that "developments in Afghanistan may bring back difficult memories for warriors and their families." The group urged anyone needing assistance to contact their counselors at 888-997-2586 or through the organization's web site.

Officials from Iraq and Afghanistan Veterans of America said veterans who served in the recent wars should remember that their service "was important and mattered." The organization's Quick Reaction Force for help is available online and at 855-917-274.

In a statement, VA Secretary Denis McDonough said that all Americans should remember the debt owed to veterans for their service. "They made our world infinitely safer," he said. "Their service did not come without sacrifice as some carry physical and emotional wounds. We must ensure they get the world-class care they've earned and deserve."

DOD RELIEF EFFORTS TO HAITI

The Defense Department's joint task force continues to support relief efforts for the island nation as it recovers from back-to-back natural disasters. As of Aug. 24, the joint task force has conducted more than 346 missions across air, land, and sea since arriving in Haiti, assisting or saving "over 436 lives" and delivering more than 163,000 pounds of aid supplies, officials said.
