NEW MEDAL OF HONOR MUSEUM

Groundbreaking was held on March 25, 2022 for the new Medal of Honor Museum to be built in Arlington. It is expected to be complete in 2024. The museum – the first of its kind in the U.S. – will share stories of the more than 3,500 recipients of the Medal of Honor, the nation's highest award for valor in combat. Of the recipients, there are 66 living and 15 were able to attend the ceremony. The museum will sit along Mark Holtz Lake at the former Dr. Pepper Ballpark site in North Arlington.

TWO STATE PROSITIONS ON MAY 7 ELECTION BALLOT

Texas Proposition 1, the Property Tax Limit Reduction for Elderly and Disabled Residents Amendment, is on the ballot in Texas as a legislatively referred constitutional amendment on May 7, 2022.

- A "yes" vote supports amending the state constitution to authorize the state legislature to reduce the property tax limit for school maintenance and operations taxes imposed on the homesteads of elderly or disabled residents to reflect any tax rate reduction enacted by law from the preceding tax year.
- A "no" vote opposes this amendment, which would have extended a tax limit reduction to the homesteads of elderly or disabled residents whose tax rates are frozen when they turn 65 or buy a new property.

Texas Proposition 2, the Increased Homestead Exemption for School District Property Taxes Amendment, is on the ballot as a legislatively referred constitutional amendment on May 7, 2022.

- A "yes" vote <u>supports</u> increasing the homestead exemption for school district property taxes from \$25,000 to \$40,000.
- A "no" vote <u>opposes</u> the increasing the homestead exemption for school district property taxes to \$40,000, thereby maintaining the existing amount of \$25,000.

LOCAL EVENT WITH OPENING OF FIRE STATION #6

The City of Waco officially opened the newest Fire Station serving the Sanger-Heights neighborhood at the end of March. Fire Station #6 is positioned on the former site of the historical 25th Street Theater building at 1006 N. 25th Street in Waco. With a not to the design of the former theater, including the neon sign and marquee, inside the fire administration building, you will find a wall dedicated to its history in Waco. The two-bay fire station itself is located at rear of the corner building. The new fire station replaces the prior Fire Station #6, which was located at 2800 Bosque Blvd built in 1940.

The 25th Street Theater was a staple in Waco history. Opening in 1945, it had air conditioning, a wide screen, and 780 seats. The average cost of an evening show at that time was 40 cents. Many Wacoan' have memories of seeing their first movie there as a child, and also remember when it closed in 1982.

<u>GUEST SPEAKER – JOHN ALEXANDER</u>

John Alexander is the Executive Director of Waco Habitat for Humanity, a position he held from 1998 – 2013 and then again from 2019 to the present. He and his wife, Ruth, have two children: a 26-year-old daughter and a 21-year-old son. John was raised in Clear Lake City, Texas.

After graduating from Texas A&M in 1986, John worked with Habitat for Humanity International in Georgia for five years as a fulltime volunteer. He and his wife then served with the Mennonite Central Committee in Nicaragua for three years. They moved to Waco in 1996, where John began working with Waco Habitat as Construction Supervisor. He attends Hope Fellowship (Mennonite) Church in Waco.

WHITE HOUSE BUDGET PLANS FOR MILITARY

Service members would see their largest pay raise in two decades under the fiscal 2023 federal budget plan released by the White House Monday.

The \$733 billion spending proposal includes a 4.6% pay raise set to start next January as well as a new basic needs allowance to help military families living near or below the federal poverty line. But the plan would also shrink active-duty military end strength by thousands of personnel.

Lawmakers will spend the next several months debating and dissecting the White House spending outline, likely making numerous changes before a final compromise budget is reached. But the plan represents a starting point for those debates, and likely the lowest-possible level for personnel items such as the pay raise.

The last time the military pay raise was above 4.0% was in 2003 (when it was also 4.6%). In January, the raise was at 2.7%, and the figure has hovered around that mark for the past five years. But soaring inflation rates over the last year led to a rise in civilian sector wages, which in turn led to an increase in the federal formula used to calculate the military pay raise.

<u>WHITE HOUSE BUDGET PROPOSAL FOR</u> <u>VA</u>

The White House is requesting an 11% boost to the Department of Veterans Affairs budget for 2023, money that would fund anticipated increases in medical costs, expand the family caregiver program and provide for several capital improvement projects at medical centers and cemeteries.

The \$301 billion proposal marks the first time the VA's budget would exceed \$300 billion -more than six times what it was in fiscal 2001, just before the 9/11 attacks and subsequent wars in Iraq and Afghanistan -- and moves the department second only to the Defense Department in discretionary spending.

Under the plan, mandatory spending, outlays the VA is required to pay including veterans disability compensation, life insurance and indemnity payouts and transition benefits, would see a nearly 6% increase to \$161 billion.

Discretionary spending at VA would rise to \$139 billion or 18.7% more than the department's 2022 budget. In a statement accompanying the budget documents, VA Secretary Denis McDonough said in a press release the plan would deliver "critical resources to help VA serve Veterans, their families, caregivers and survivors as well as they have served our country."

According to the proposal, the department's medical care budget would rise by 22%, to nearly \$119 billion, to address health-care inflation, anticipated increases in enrollment, growth of private sector care and expansion of other programs.

The plan calls for bolstering the budget for in-house VA medical care by 20%, to \$70.6 billion, and for VA-covered private health services, also known as community care, by 22% to \$28.5 billion. It would increase funding for mental health-care programs by 15% to \$8.5 billion and for prosthetics care, to \$4 billion, up 8%.

VA's caregiver services also would see an increase in fiscal 2023, with the department proposing a 31% increase, or a total of \$1.8 billion, to compensate those enrolled in the Program of Comprehensive Assistance for Family Caregivers. The increase would allow VA to cover caregivers expected to apply after eligibility broadens on Oct. 1, 2023 to include seriously injured and disabled combat veterans who served from May 7, 1975, to Sept. 10, 2001. Also, it would enable VA to continue assessing and processing 109,000 applications it has received since last October from veterans who served during the Vietnam War and earlier, while also considering appeals from those who were dismissed from the program, according to the budget documents.

The VA announced at end of March that it was pausing reviews that could force up to 90% of caregivers from that program, an unintentionally high figure according to officials. The budget also includes additional funding to combat veterans' homelessness and fund suicide prevention programs, to include hiring more staff to man the Veterans Crisis Line and assist as it transitions to the new three-digit 988 phone number.

The department also said it will expand women's health-care services, requesting \$767 million for gender specific care and to support efforts to improve access to maternity care, obstetrics and gynecological care.

The VA is also planning to ask Congress for legislation that would allow it to expand veterans' access to fertility services, to include covering in vitro fertilization and adoption reimbursement for some veterans, and to eliminate copayments for contraception care and services.

Also included in the proposed budget is \$2.3 billion to fund construction and improvements at several major medical facilities, including seismic upgrades to facilities in Portland, Oregon, and Fort Harrison, Montana, and constructions and renovations in Canandaigua, New York, as well as construction or replacement of at least two cemeteries. An additional \$789 million would be marked to start minor construction projects, and \$80 million would go toward building VA's zero emission vehicle fleet.

With the release of President Joe Biden's budget, Congress will begin deliberations over funding and develop its own spending package, with a goal to complete it by Oct. 1.

MOAA MAGAZINE ADVOCACY TEAR OUT LETTERS

The April issue had four tear out letters for consideration to complete and send to elected officials. This is to request support for the Star Act (S. 344 and H.R. 1282) that would enable more than 50,300 combat –injured veterans to receive both their vested longevity pay and VA disability.
