PRESIDENT'S COLUMN

Greetings

We are dedicated to improving our status as a premier veteran's organization through increased volunteer and financial support for veterans, veteran dependents, and JROTC/ROTC students. Through our scholarship and grant programs, we help prepare those who will lead in the future. Our donations to local and national veteran support organizations will assist those who are serving, have honorably served our nation and their dependents.

Simply stated, our leadership team's 2023 Chapter/Foundation goals and objectives focus on four areas:

- Become the recognized leader in supporting uniformed services veterans (active/retired/ honorably discharged) and their families in Texas
- 2. Maintain sound financial status
- 3. Complete website modernization
- 4. Apply for and receive MOAA Levels of Excellence Award (chapter), Col. Marvin J. Harris Communications Award (chapter), Leadership Award (member) and Chairman's Award (member)

Only a sound financial organization can achieve these objectives. This January, Bill Hulsey completed an internal review of our financials, both Chapter and Foundation, and concluded that we are financially sound.

Last month, our Board of Directors <u>approved</u> the leadership team's proposed Chapter 2023 budget, which after all expenses are paid, will yield an end of year balance of \$7,220.

Next month, the Board will decide whether or not approve the leadership team's recommended Foundation (Benevolence) Fund 2023 budget.

Aside for volunteerism, our proposal is two-fold:

- 1. To increase scholarship and grants
- 2. To increase local and national donations

The leadership team recommends that we increase our scholarship (Goodall and Freedom is not Free) funding from \$10,000 to \$12,000 and our Baylor Air Force ROTC and Army ROTC grants for \$600 each to \$1,000 each. Grants to JROTC remain unchanged.

From 2007-2022, the Foundation's donations to veteran's organizations averaged only \$553 per year. This year, the leadership team proposes to donate \$3,500 to local veteran's organizations and \$3,000 to national veteran's organizations.

If approved, the Foundation budget, after all expenses are paid, will yield an estimated end of year balance of \$11,681. (This excludes our Certificate of Deposit of over \$36,000.) The Board's decision will directly affect if we are recognized as a "premier veteran's organization" in Texas.

I call upon each of **YOU** to help make our fundraising efforts a success through individual donations, by working with the Fundraising Team in soliciting donations from businesses and individuals, and/or volunteering to help at the golf tournament. As of March 1, five members have already donated over \$4,000 to our fundraising effort. Please contact Vince Tobola to donate and for more details on soliciting donations and/or helping at the golf tournament. *Remember, a portion of our Chapter Coin sales go to our fundraising*.

Lastly, let's not forget the <u>sacrifices</u> made since the founding during: Revolutionary War, Civil War, World Wars I & II, Korea, Vietnam, Grenada, Panama, former Yugoslavia, Africa & Mid-East (Somalia, Libya, Iraq, Afghanistan, ISIS, Cold War)

NEW MEMBERS

FREE LEGAL ADVICE FOR VETERANS

VA AND HOUSING THE HOMELESS

Veterans Affairs staffers helped more than 40,000 veterans in to permanent housing last year, surpassing the department's goal and establishing new pathways to help individuals in need, officials announced at end of January.

CONCURRENT RECEIPT BILL

The Major Richard Star Act, legislation which would end an unfair pay offset faced by more than 50,000 combat-injured veterans, was reintroduced in the Senate on Feb. 9 and already has amassed 49 cosponsors. S-344 introduced by Sens. Jon Tester (D-Mont.) and Mike Crapo (R-Idaho), would allow medically retired, combat-injured veterans with less than 20 years of service to receive full DoD retirement pay and VA disability pay, instead of losing hundreds of dollars a month to cover the current unfair offset. Last year, over two-thirds of Congress supported the Star Act, with 67 Senate cosponsors and another 336 in the House. The House will reintroduce its bill soon; advocates hope to build on last year's support and grow the number of original co-sponsors, creating a path to passage as standalone legislation or as part of the annual National Defense Authorization Act (NDAA).

Coalition members met with lawmakers and staffs throughout day on February 28 and were joined by Sen. John Tester (D-Mont.) and Rep. Gus Bilirakis (R-Fla.) in a same day press conference calling for swift passage of the bipartisan legislation, which would allow combat-injured veterans to receive both vested longevity pay and VA disability. The retirement pay of these veterans is currently subject to an offset, reduced by a dollar for every dollar of VA disability received. The bill is named after Maj. Richard Star, an Army combat engineer who died of cancer in 2021. He dedicated his final months of life to calling for a change to this unjust law.

VIETNAM WAR VETERANS DAY

March 29 this year marks the 50th anniversary of U.S. combat troops returning home from the Vietnam War. The date is now known as National Vietnam War Veterans Day.

The day was first proclaimed by President Obama in 2012. President Trump subsequently signed it into law in 2017.

It is a day to thank and honor all veterans show served in the war. The legislation, The Vietnam War Veterans Recognition Act of 2017 (P.L. 115-15), annual recognizes March 29 as National Vietnam War Veterans Day. It also amended Title 4 of the U.S. Code to "encourage the display of" the U.S. flag on March 29.

20 YEARS LATER AND IRAQ INVASION

The Iraq War began on March 19, 2003, when U.S. planes and warships based in the Persian Gulf hit targets within Iraq with a barrage of Tomahawk missiles. The next day, the ground phase of the war started when the first of 160,000 U.S. troops entered Iraq.

The invasion was swift and successful. During the first wee, Marines encountered heavy resistance near the southern Iraq city of Nasirayah, which the Marines called "the wild west". By April 0, after a six-day battle, U.S. forces had captured Iraq's capital of Baghdad. On May 1, President George W. Bush declared that the first phase of the war was complete.

TEXAS VETERANS LAND BOARD

The Veterans Land Board has approved an increase for our home loan amount from \$647,200 to \$726,200. Eligible Texas Veterans and Military Members can now apply for VA, FHA or conventional financing using the Veterans Housing Assistance Program (VHAP) and a VLB participating lender.

When used with VA-backed home-buying benefits, Veterans may be eligible for a home loan with no down payment and no private mortgage insurance (PMI).

VA AND EMERGENCY MENTAL HEALTH

All veterans are now able to access emergency mental health free of charge as tany Veterans Affairs medical facility or outside clinic, regardless of whether they are enrolled in departmet health care services.

Department officials announced the new policy January 13 as part of the nationwide efforts to prevent veteran suicide. According to the latest department data, about 17 veterans a day die by suicide.

The new policy aplies to all veterans with any separation status except a dishonorable discharge, regardless of whether they qualify for other VA medical services.

About 18 million veterans are living in America today, but only about half are currently enrolled in vterans health care through the department.

Since 2019, all VA medical facilities have been required toprovide same-day access to emergency mental health care to veterans.
