## <u>MEMBER SPOTLIGHT –JIMMIE HANES, --</u> <u>FORMER CHAPTER PRESIDENT</u>



Colonel Jimmie W. Hanes Jr, USAF (Ret.), was born and raised in Enon, Ohio. He graduated from Greenon High School where he was a student athlete and in 2019 was elected to the school's Hall of Fame. After graduation he

attended Hiram College where he earned a Bachelor of Arts Degree in Social Science. At Hiram, he was an NCAA and conference hurdle champion, winner of the first Athlete of the Year award and in 1992, selected for the college Athletic Hall of Fame. Following graduation from Hiram, He joined the Air Force. While in the Air force, Jimmie earned a Master's Degree in Public Administration and became a Baylor University Alumni by Choice.

Highlights of his 29 year Air Force career include:

- 107 combat missions in the Vietnam War, of these, 100 were over North Vietnam
- Over 3600 hours of flying time primarily in bomber aircraft
- One of 15 senior officers selected to the highly competitive Air Force Research Associates program
- United States Defense/Air Attaché to the Sultanate of Oman
- Deputy Director of Bomber Operations at Strategic Air Command (SAC) Headquarters and Deputy Chief of Staff of the SAC Command Post during Operation Desert Shield, the precursor to Operation Desert Storm
- Base Commander, Wurtsmith AFB, MI.
- Military awards include: the Legion of Merit, Distinguished Flying Cross, Air Medal with ten oak leaf clusters, Defense and Air Force Meritorious Service Medals

Upon retirement from the Air Force, Colonel Hanes was a City Manager in two Michigan cities, earning two State of Michigan outstanding service awards, as well as recognition by the Harvard University, JFK School of Government, for innovative leadership.

Jimmie moved to Waco, TX to be the Director of Aviation Services at Waco Municipal Airport and then spent several years as Director of Development for Advanced Concepts and Technologies International. He has served as President of the North Bosque Water Supply Corporation, Chairman of the Board of Lutheran Sunset Ministries, President of Ridgewood Country Club, President of HOT MOAA Chapter, and serves on several other Boards or committees, including the Baylor University Bear Foundation, Lady Bears Tip-Off Club, First United Methodist church, Veteran's One Stop and various other civic organizations.

Jimmie married a former Baylor coed (Mary Hoel: BA 1966) and he and Mary have two children and six grandchildren. After 22 relocations in Jim's career, he and Mary are settled now and live in Crawford, TX.

## <u>CHANGES FOR RECEIVING VA BENEFITS</u> <u>INTO MULTIPLE ACCOUNTS</u>

Veterans will no longer be able to use multiple bank accounts for different Veterans Affairs benefits under new anti-fraud measures being rolled out by department officials over the next two months.

The move is expected to affect about 50,000 current GI Bill users who also receive other veterans stipends, but VA leaders are promising they will not cut off benefits to anyone as a result of the changes. Instead, if veterans fail to consolidate their bank accounts by April 20, department processors will begin sending all of the benefits to a single account. Still, such a move could cause significant financial problems for individuals expecting to find the money in a specific account to cover bills and expenses.

Officials said they will spend the next two months aggressively contacting the thousands of student veterans potentially impacted by the new rule, and explaining the reasons behind it.

Maintaining a single account for the payment of this benefit provides an added layer of security against the increasing threats of fraud we experience as part of our daily lives," VA Undersecretary for Benefits Joshua Jacobs told reporters at end of February. "Veterans have earned these benefits through their service to the nation. And ensuring they're safeguarded from those with malicious intent is a significant feature of this single account initiative."

VA officials said veterans may use different bank accounts for different benefits for a variety of reasons, including ease of bill paying and simply forgetting to update old accounts.

But Jacobs warned that such an arrangement makes it easier for fraud or theft and harder for VA officials to provide oversight of the funds. He said the changes come as "we are working to modernize our payment systems so we can protect the integrity of the veterans benefits" across multiple systems.

## NEW ENROLLMENT COMING FOR PACT

- Millions of U.S. veterans will be eligible beginning March 5 for health care with the Department of Veterans Affairs under an accelerated effort to provide benefits and services to those exposed to toxic substances while serving. The VA announced at end of February that all veterans who have served in a combat zone since the Vietnam War, as well as those who participated in training or operations and came into contact with hazardous materials, will be able to enroll in VA health care.
- The expansion of health care benefits was mandated by the PACT Act, signed into law by President Joe Biden in August 2022. VA officials said last month the acceleration is a result of a hiring blitz made possible by provisions in the law. Under the PACT Act, more than 100,000 veterans have enrolled in VA health care and roughly 760,000 disability claims have been approved. VA officials did not detail exactly how many veterans now will be eligible for care under the expansion but said the figure is in the "millions."
- The expansion allows all veterans who deployed to combat zones in support of the Vietnam, Persian Gulf, Iraq and Afghanistan wars to enroll in VA health care. In addition, veterans who never deployed but were exposed to pollutants while participating in a known "toxic exposure risk activity," or TERA, either in the U.S. or abroad, will be eligible.
- That would include exposure while on active duty, active-duty training or inactive-duty training to: air pollutants from burn pits, particulate matter, sulfur or oil well fires; chemicals such as pesticides, herbicides, contaminated water or depleted uranium from embedded shrapnel; occupational hazards such as lead, industrial solvents, toxic paint, asbestos and firefighting foam; radiation, including nuclear weapons handling, maintenance and detonation, X-rays and occupational exposure; and chemical or biological weapons or nerve agents.
- According to the VA, the department will use service records and other resources to determine whether a veteran participated in a TERA.
- Veterans are not required to have a serviceconnected disability or file a compensation

claim to be eligible for VA care. New enrollees will have access to a toxic exposure screening provided by their primary care physician and may be referred to specialty care depending on need, Elnahal said during a call with reporters last month.

- They also will be assessed for placement in the VA's priority-based health system and referred to the Veterans Benefits Administration if they qualify for additional benefits.
- Priority group placement determines whether a veteran is required to make copayments for appointments or prescriptions, depending on treatment or the medications.
- During a press conference, Elnahal said that, by law, veterans receiving treatment for exposure-related illnesses will not make copayments for appointments related to that care.
- The Veterans Health Administration has set a goal to hire 52,000 employees this fiscal year, which, when factoring in attrition, should grow its workforce by 3%. Elnahal said the increases could help to absorb new patients, meet demand and standardize or even improve wait times.
- The VA is encouraging veterans to apply for care or benefits by visiting the VA.gov/PACT website or calling 1-800-MYVA411.
